A. One (1) copy drawn to scale with the following information:

- 1. Name of the subdivider, location by section, town, range and township, date, north point, scale, and acreage to hundredths of acre.
- 2. Name of the registered surveyor who prepared the map, including registration numbers and seals.
- 3. Lot lines and dimensions, based on a survey.
- 4. Adjacent street names and centerlines.
- 5. All existing buildings, septic facilities and wells if applicable.

B. Supplementary Information

Any of the following information will be required by the Commission on the basis of the characteristics of the subject property:

- 1. Lot grading and drainage plan, illustrating a plan for the handling of surface and subsurface drainage, and/or a statement from the Montgomery County Soil and Water Conservation District that there is adequate drainage.
- 2. Spot elevations.
- 3. Approval by the Health Department if on-site sewage disposal systems are being proposed.
- 4. Evidence that there is adequate ground water if public water is not available. This will require a test well on each lot which must produce at least five (5) gallons per minute for six (6) hours of pumping.
- 5. A written statement from the proper authorities that a tap-in is permitted if the property is served by public sewer and water.
- 6. 100-Year Flood Plain elevations and delineations.
- 7. Other information as deemed necessary by staff in order to create building sites and promote the public health, safety and welfare.
- 8. Zoning Approval. A written statement from the proper authorities that the proposed lot split complies with local zoning requirements.
